### Do I need to renew my employee donor pledge each year?

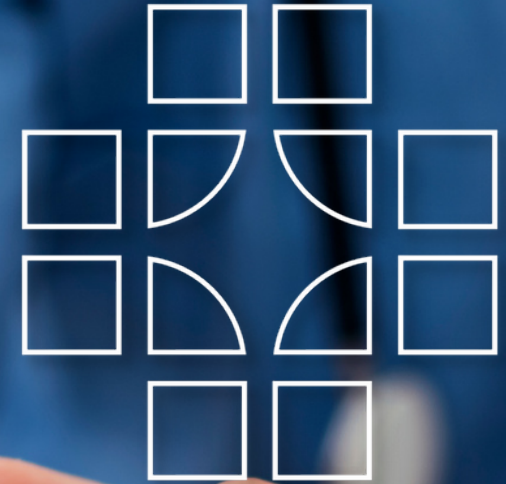

The Cornerstone program aids EAMC employees in a financial crisis, grants down payments to qualifying employees, and supports disaster relief locally and regionally. Your contribution can be designated to one or all three programs.

HEALTHCARE EMPLOYEES REACHING OUT



Funds raised through Healthcare Employees Reaching Out (HERO) will benefit the following funds:

### CPAP Assistance Fund

Help patients get the testing and CPAP equipment they need to improve breathing levels and oxygen saturation during sleep. In FY21, 18 patients received CPAP machines funded by HERO funds.

### Psychiatry Fund

Provides clothing, shoes, and hygiene items for adolescents in DHR custody who arrive with few possessions. This year, the fund would like to purchase a second picnic table for the courtyard.

### EAMC Diabetes and Nutrition Center

Allows patients without health insurance to visit our endocrinologist. The fund also sends 8-10 children with diabetes to Camp Seale Harris, where they meet other children like them and learn more about diabetes and health.

### Outpatient Cardiac Rehab Program

Provides funding for patients who have had a cardiac event such as bypass surgery or heart attack and who cannot attend Cardiac Rehab without financial help. In FY21, HERO funds assisted 31 patients.

### NICU and Pediatric Patient and Family Assistance Fund

Provides the funding for EAMC's child life specialists program and car seats, pack-n-plays, clothing, and breast pumps for qualifying families.

### Patient Crisis Fund

Helps patients and families in crisis situations. It is not uncommon to assist with lodging, transportation, food, and lumber for wheelchair ramps.

### Transition Fund

Assists patients with barriers to discharge. The fund provides medical equipment such as oxygen, CPAP, or Autopap devices for patients with lack the funds or insurance coverage to purchase. Discharge transportation, medicine, and temporary housing can also be provided.
